ELECTION OF CHAIR AND VICE CHAIR; Cllr. Crawford proposed and Cllr. Paul seconded Cllr Bennett continue as chair. Cllr. Paul and Cllr. Hatton seconded Cllr. Crawford continue as vice chair.

Proposed tree works to horse chestnut at St. Olaves House. No objection.

Reply sent to Director of Planning in accordance with previous minutes. Copies of relevant correspondence in connection with this sent to John Shears following annual meeting. Email from Paul Weston re. nieghbourhood plans circulated. Cllr. Bennett confirmed that in accordance with Localism Act, that the production of a neighbourhood plan, if relevant, was now responsibility of Parish Council. The plan would have to fit with the structure plan and would be used as a base line for dealing with new applications and a process would have to be worked through. Cllr. Bennett requested that this be kept alive and discussed at future meetings.
